Director Talmage updated the Board on the process of the RAD Development Closings and reported that all parties had indicated they anticipated closing at the end of October or in November 2024.

Director Talmage reported the BCHC Strategic Planning event was scheduled for November 26, 2024 at the Miller Foundation. Dr. Crain, the event's facilitator was working with Talmage to prepare the agenda utilizing documents that had been forwarded to her. As November 26, 2024 was the scheduled Tuesday before the Thanksgiving holiday, and coincides with the November 2024 regular Commission meeting, it was suggested the regular meeting be moved back to November 17, 2024 or cancelled. As the Planning event is intended to support the regular mission of the Commission, the Board decided to cancel the regular November 2024 meeting.

Regarding the True Care Living Project Based Voucher initiative and the national HCV Shortfall situation, Talmage stated he had two phone meetings with Eli Gabay and Attorney Garrett McDaniel regarding Shortfall and the impact on this PBV proposal.

Deputy Director Paternoster reported on the recent occupancy challenges and let the Commission know he was working with the Asset Managers to prepare for removing the Commission's residents out of the HUD Real Estate Assessment Center (REAC) PHA Information Center (PIC) as soon as the last three sites are converted.

Committee Reports:

Director Talmage reported that interviews were being set up with the two potential candidates for the Deputy Director of Development position. Dates for the Commissioners were then narrowed down to the first two weeks in November, and then November 14, 2024. Director Talmage stated he would call the two candidates about their availability and then confirm with the Board.
